What we do

We have a dedicated team who work with the person and their supporter to ensure we offer a high-quality assessment and treatment process, taking everyone's needs into account.

We will undertake a comprehensive assessment, recommend suitable investigations and diagnose the nature of the memory difficulties. We provide a fast, discreet and economic means to get a medical diagnosis and treatment through our own secure video portal.

The team includes Consultant Psychiatrists, Specialist Memory Nurses, Specialist Psychologists, Occupational Therapists and a dedicated administration team. Any findings are generally reported to the patient's General Practitioner (GP).

After diagnosis, we can provide a range of treatment interventions to both individuals and groups.

Medication titration and post-diagnostic support are also included as part of our package.

We recognise that every patient's journey is different, and our patient pathways are therefore designed especially for you.

Specialist nurse screening assessment

Following your referral, we will arrange an appointment with one of our Specialist Memory Nurses who will conduct a cognitive examination.

They will also spend time discussing your concerns to gain an understanding of how your symptoms are impacting your day-to-day life, and gather patient history.

Medical investigations

Once all the information has been collected, this is sent onto your Consultant for review. Your Consultant may recommend further investigations, such as blood screening, urine analysis, ECG, CT/MRI brain scan and further memory testing, including a neuro-psychology examination.

Consultant diagnostic review

When your Consultant has all the necessary information, we will invite you to a virtual appointment to discuss the outcome of your assessment and advised treatment plan.

Post-diagnostic support

Following any dementia diagnosis, we will be able to offer post-diagnostic support, including a range of treatments. These could include:

- Commencement and monitoring of Dementia medication
- Cognitive Stimulation Group sessions
- Health Needs Assessments

Talk to your loved ones

If you are seeking a memory assessment for yourself, it is advised that you are supported through the assessment process by someone who knows you well. If you are booking an appointment on behalf of someone else, please discuss the assessment process with them to ensure they are involved in the process and know what to expect.



Ready to book your appointment?

There are a couple of ways you can book your Memory Assessment.

- You can call our friendly and knowledgeable patient services team, who will be happy to book in a date and time that suits you. Our waiting times are very short and we do not need a referral from your GP.
- 2. If you prefer, you can complete an online booking form and a member of our team will contact you.



How to attend your appointment

Once we have your details we will create a record for you on our secure Patient Portal. You will be able to use your personal login to communicate with your Consultant and view any patient letters. You will be emailed a link and passcode to access all of your virtual appointments via the Patient Portal.



Information gathering and consent

With your consent, we will request a GP patient summary/profile from your GP to provide us with your health history and a list of any current medications. We may require additional information via a neuro-psychology assessment.

Our fees

Assessment

Initial Nurse Screening Assessment - £150

As well as gathering important information, our Specialist Nursing Team will conduct an Addenbrookes Cognitive Examination (ACEIII) in preparation for your Consultant Diagnostic Assessment.

Blood and Urine Screening - From £295

We work in partnership with Phlebotomy services, who can visit you within your own home. These tests can be arranged by us at any time and date convenient to you.

Investigations required prior to Consultant Diagnostic Assessment

CT Scan - £500

This price will vary depending on your location and will be quoted on an individual basis. We can arrange your scan for you at a location, date and time convenient to you.

MRI Scan - £400

These prices will vary depending on location and will be quoted on an individual basis. We can arrange your scan for you at a location, date and time convenient to you.

Consultant Diagnostic Assessment - £600

Appointment with your Consultant to review the nurse's findings and discuss any diagnosis and ongoing recommendations. These may include advice around finances, driving, will writing etc.



Post Diagnostic Support

Medication Titration - £360 (Nurse-led) or £610 (Consultant-led)

If you would like to commence medication, our dedicated nurse titration team will work with you to establish a personalised care plan and support you over a 12-week period.

Prescription and delivery costs - £25

6 to 12-week follow-up with Consultant - £250*

30-minute appointment. Option to see your Consultant again following your diagnosis to discuss a personal care pathway.

6-month follow-up with Consultant - £250*

30-minute appointment. Option to see your Consultant for a 6-month review, following initiation of your treatment pathway.

Annual follow-up with Consultant - £400

Option to return for an annual review, where we discuss your ongoing treatment pathway and repeat your ACEIII cognitive exam.
